The Struggle of a Person with Tourette Syndrome for Being a Teacher as Seen in "Front of The Class" Movie By Peter Werner

ABSTRACT

This study analyze the struggle of a Person with Tourette syndrome for being a teacher in "Front of The Class" movie by Peter Werner. The aims of this research are to identify the characteristics of a Person with Tourette syndrome and the kinds of struggle used by a Person with Tourette syndrome as seen in -Front of The Class|| movie by Peter Werner. This research also used James Leckman et al, American Psychiatric Association and Stephen Harrison theory to find the result of the research. Researcher used descriptive qualitative method. The source of the data in this study is "Front of The Class" Movie by Peter Werner. In the data collection, the researcher used documentation technique. Then, the data were analyzed used descriptive analysis. From the results of this research, the researcher found three of physical characteristics represented of a Person with Tourette syndrome by Brad Cohen, there are the presence of tics, tics appear between 5 or 6 years of age, and repeated tics for at least one year. The researcher also found two of the mental characteristic represented by Brad Cohen, there are hard to concentrate, demonstrate disruptive behavior (impolite) and difficulty in interpersonal relationships. Then, the researcher found two kinds of struggle used by Brad Cohen, internal struggle and external struggle. Internal struggle are Brad holding tics to study, Brad tries to convince recruiter and register to be a teacher in various school. External struggle are struggle from Brad's family and struggle from Brad's principal (Mr. Myer).

In Centers for Disease Control and Prevention (2022) states that Tourette syndrome (TS) is a condition of the nervous system that makes sufferers have 'tics' which are sudden twitches, movements, or sounds that they do repeatedly. In accoordance with that point, it is fascinating to describe characteristics and identify the kinds of struggle by a Person with Tourette syndrome. The researcher formulated the following research questions:

- 1. What are the characteristics of a Person with Tourette syndrome as seen in Front of the Class|| Movie by Peter Werner?
- 2. What are the kinds of struggle used by a Person with Tourette syndrome as seen in Front of the Class|| Movie by Peter Werner?

Literature Review

Physicological Approach

Tourette Syndrome

Tourette syndrome is a condition of the nervous system that makes sufferers have 'tics'. In Leckman et al. (2001) states that, —Tics are a curious assemblage of abrupt repetitive movement and sound or tics are sudden, repetitive, occasionally stereotyped movement or sounds that involve discrete muscle groups. Said an other way, tics are isolated, perhaps innate, framents of normal motor or vokal behaviours that occur out of context. For example, a sufferer might grunt unwillingly. Chronic form of Tourette's syndrome, beginning in childhood, where children are susceptible to simple motor tic attacks, such as jerking their heads or blinking their eyes.

Physical Characteristics

- a. The Presence of Tics: Tics can be characterized by their anatomic location, frequency, intensity and complexity. Tics have two variaties, motor tics and vocal tics.
- b. Tics Appear Between The Ages Of 5 Or 6 Years: This condition typically begins in childhood, usually between the ages of 5 and 6, and can also peak between the ages of 7 and 15.
- c. Characterized By Repeated Tics: For At Least One Year Motor and phonic tics occur in brief bursts throughout the day and vary in severity over several weeks, months, or even years (Leckman et al, 2001). It indicates that tics occur frequently, or frequently on most days.
- d. Their Suppressibility and Suggestibility: Almost always, patients can willfully hold back their tics for brief periods of time, they can.

Mental Characteristics

a. Many Person with Tourette syndrome with mild to average tic severity experience no trouble or impairment in functioning, and may even be unconscious of their tics.

- b. More Aggressive Symmetry: Some people with tic severity experience obsessions, which usually include recurring thoughts of aggressive actions.
- c. Hard To Concentrate: Hard to concentrate, which can hinder activities and hinder productivity at work or in school.
- d. Anxiet Disorders, Namely Fear, Chame and Excessive Anxiety: People with Tourette's syndrome can experience anxiety disorders that can be felt at any time, even without a clear stress trigger.
- e. Demonstrate Disruptive Behavior (Impolite) and Difficulty: In Interpersonal Relationships A person with Tourette syndrome might respond to a gesture or sound they see in another person by making a similar gesture or sound, which other people might think was made with purpose.

The Struggle

Struggle is a process made by someone in their life in realizing things that are desired and achieving things better. Of course, in order to achieve what is desired and dreams of, one must try hard and enthusiastically. According to Harrison (2012), Struggle is not necessarily a bad thing. If we struggle to right a wrong, it hurts, there is pain involved, but the outcome is dsirable.

- a. Internal Struggle According to Harrison (2012), —Internal struggle includes conflict arising within ourselves, the sources of which include our attitudes, desires, choices, understanding or interpretation of life, habits, attachments to people or situations, and our expectation of how things ought to be.
- b. External Struggle External struggle occurs at global, international, and social levels. It is any location where two or more people have a relationship. Examples include fights between siblings, arguments between parents, war, political revolutions, and worker strikes against employers (Harrison, 2012).

Method

Instrument and Data Analysis

The research design for this study was qualitative method. The data is the movie that related to the research. In this research, the researcher took the data from in "Front of the Class" movie is a 2008 America movie and co-produced by Peter Werner, adapted from the real-life story of Brad Cohen who had Tourette syndrome and dreamed of becoming a teacher. The researcher did some steps in analyzing the data theory of Miles, Huberman & Saldana (2014). The steps are data reduction, data display, conclusion.

- a. Data Reduction Miles: Before making data reduction, the researcher collected data based on the results of the documentation. After the data collection stage is carried out, the researcher selected the most important information. Then, the researcher identified the data that related to the research questions.
- b. Data Display: In this case, the researcher displays data in the form of a flowchart and a narrative in the form of descriptive data from qualitative research. The researcher described data based on the theory of struggle by Stephan Harrison, theory about characteristic of Person with Tourette syndrome by James Leckman et al., and American Psychiatric Association.
- c. Conclusion: In this case, the researcher drew conclusions based on valid data by explaining the problems at the beginning and then making a summary of what has been described, then connecting the data or facts that have been obtained with the core of the problem to be searched to get an overview of the results that have been studied.

This is an example of a person with Tourette syndrome who is constantly making movements, which can be physically assessed based on the sense of human vision. The data above was closely related to the theory used in this research, where common examples of simple motor tics include twitches, mouth movement, and head jerks (Leckman et al., 2001).

Where it is described that Brad makes a sound like a dog barking beyond Brad's control. The data above was closely related to the theory of simple phonic tics, where simple phonic tics are meaningless sounds or noises (Leckman et al., 2001).

Based on the results above, it can be concluded that "Front of The Class" movie can be a reflection of characteristics of person with Tourette syndrome and being a teacher is not an easy process for person with Tourette syndrome, including Brad. Being a teacher is a calling for Brad, not necessarily a financial one. Even though, Brad has Tourette syndrome, he never gives up and never allows his tics to win.
